Safe In India Foundation: Industrial Worker wage payment assessment during COVID-19 in Gurgaon as at 15Apr20

Purpose: To understand whether even formal workers, registered with ESIC and assisted by SII in the past have been paid for March 2020 as required under GOI guidance note. GOI order 40-3/2020-DM I(A) dated 29 March 2020 and Haryana order issued on the same day.

- Out of 50 workers who are paid on a monthly basis, 18 workers ie. 37 percent have still not received their salary for the month of March as on 15Apr20.
- Only 17 workers out of 50, ie. 35 percent workers received full salary without any deduction for the month of March. However, most of them are not certain whether this amount paid is in fact an advance that will be deducted later from their future salaries or whether any monies will have a deduction for the

Murli, based in Bawal, Rewari says: "I have received my salary for March after deduction. The HR has said that once the lockdown is lifted, I will be given arrears or that amount will be credited into my account. I have been informed by the HR that a sum of INR 1,000 has been deducted for everyone."

Raju Singh, based in Kasan, Manesar says: "I called up my contractor to clarify

whether other workers are getting wages

payment made for the lockdown period in March. We will review this again in early May20, along with any other cash/kind support received during this period from the government/other agencies.

• 14 workers out of 50 ie. 28 percent received payments with some deductions.

We also asked about the role played by their contractor in reaching out to them or being available to the worker to discuss any assistance that he/she might need with his/her food and financial requirement during this sudden crisis:

- Only 30 of the 50, 60 percent respondents were proactively informed by the Contractor or the factory owner about the lockdown. The remaining 40 percent came to know about it mostly from security guards, notices at the gates, friends/colleagues or

about this and only one worker was told about monetary/ relief measures during the lockdown.

 Although only one worker was told about relief as above, many workers called for help but only 10 workers out of the 50 ie. 20 percent workers were finally assisted by the contractor/company. Nine of these received either donation or advance payments and one was assisted by way of dry ration supply.
